Commitment to achieving Net Zero

CliniMed Ltd and SecuriCare (Medical) Ltd are committed to achieving Net Zero emissions by 2045.

Additional Details relating to the Baseline Emissions calculations.
<p>CliniMed Ltd and SecuriCare (Medical) Ltd have been working on reducing emissions since 2012. We have selected 2021 as the base line year as this is the first year for which we have all relevant emissions data as required by PPN 06/21.</p> <p>Reporting Definitions – Scopes 1, 2 and 3</p> <p>Scope 1 emissions are direct greenhouse gas emissions that occur from sources that are controlled or owned by the reporting organization. E.g., emissions associated with fuel combustion in boilers, furnaces, company vehicles.</p> <p>Scope 2 emissions are indirect greenhouse gas emissions associated with the purchase of electricity, steam, heat, or cooling. They are accounted for by the reporting organisation as they are a result of the organisation’s energy use.</p> <p>Scope 3 emissions include all sources not within an organisation’s scope 1 and 2 boundary. Scope 3 emissions often represent the majority of an organisation’s total greenhouse gas emissions. Please note that scope 3 consists of 15 categories. We are reporting on five categories currently in line with NHS England guidance. The five categories are:</p> <ul style="list-style-type: none">• Business travel (non-company car travel)• Employee commuting• Waste generated in operations• Upstream transportation and distribution• Downstream transportation and distribution

Emissions reduction targets

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

We project that carbon emissions will decrease over the next five years to 436 tCO₂e by 2030. This is a planned reduction of 22.5%

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets. We project that carbon emissions will decrease over the next years to zero by 2045 this is a reduction of 100%



Carbon Reduction Projects

Completed Carbon Reduction Initiatives

The following environmental management measures and projects have been completed or implemented since the 2021 baseline. The carbon emission reduction achieved by these schemes equate to around 298 tCO₂e, a 34.6% reduction against the 2021 baseline and the measures will be in effect when performing the contract.

- Emissions for a new business building was added to the 2024 emissions figures.
- ClinMed Ltd and SecuriCare (Medical) Ltd have had a long-standing aim to reduce emissions and have therefore opted to be accredited to the ISO14001:2015 standard. As a result, the ISO framework is threaded throughout organisational standard operating procedures and supports the action of environmental objectives. The organisational environmental management system (EMS) is supporting both organisations to reduce their emissions and waste.
- Installation of LED lighting in all business buildings.
- Introduction of working one day from home has resulted in reduction of company business travel and commuting.
- Subscribing to a carbon reporting tool to accurately record our carbon emissions.
- Introducing MS Teams and MS SharePoint has encouraged staff to use video conferencing, reducing the need for travel, emailing and printing documents.
- Purchasing of 100% renewable energy.

In the future we hope to implement further measures such as:

- Feasibility study for onsite renewable energy sources through solar panel installation.
- Feasibility study for further transition to zero emission vehicles by continually promoting electric-vehicle lease scheme

- Planning to conduct an energy audit investigation.
- Reviewing options for potential HVAC replacements
- Investigating further potential carbon reduction initiatives

Declaration and Sign Off
